### **2. What personal data we collect about you, including sensitive data**

**PMC** will not intentionally collect or maintain, and do not want you to provide any information regarding ethnic origin, political opinions religious or philosophical beliefs, trade union membership, genetic data, data concerning your health, data concerning your sex life and sexual orientation and biometric data.

### **3. How we obtain your personal data, including sensitive data**

## 5. How we protect your personal data, including sensitive data
